1. Call Meeting to Order/Establish Quorum

Director Skillman chaired and opened the meeting and stated that it was a Regular Meeting held pursuant to notice duly given. A quorum was established and the meeting was called to order at 11:37 a.m.

2. Approval of Agenda

Director Leonard made a motion to approve the agenda as presented. Director Torng seconded the motion and the motion was approved unanimously.

3. Election of Officers by Opening of Nominations and Vote

President

Absent additional nominations, the floor was closed to nominations. By way of secret ballot Director Skillman was elected President by a vote of 7 to 4.

First Vice President

Director Skillman opened the floor to nominations for First Vice President:

Director Achrekar nominated Director Dorrell for the position of First Vice President. The nomination was seconded by Director Tibbitts. Director Dorrell accepted the nomination.

Absent additional nominations, the floor was closed to nominations. By way of secret ballot Director Dorrell was elected First Vice President by a vote of 8 to 3

Treasurer

Director Skillman opened the floor to nomination for Treasurer.

Director Tibbitts nominated Director Morrison for Treasurer. The nomination was seconded by Director Achrekar. Director Morrison accepted the nomination.

Director English nominated Director Armendariz for Treasurer. The nomination was seconded by Director Bastani. Director Armendariz accepted the nomination.

Absent additional nominations, the floor was closed to nominations. By way of secret ballot Director Morrison was elected Treasurer by a vote of 7 to 4

Director Leonard made a motion to close nomination. The motion was seconded by Director Torng and the motion passed unanimously.
