









SUBJECT: Tree Removal Request: 3086-C Via Serena N. (Graham) – One Shamel Ash

tree

RECOMMENDATION

Approve the request for the removal of one Shamel Ash tree and schedule the repair of the v-ditch.

BACKGROUND

Ms. Graham purchased the manor in February 1999, and is requesting the removal of one Shamel Ash tree, *Fraxinus*, *uhdei*. The reasons cited for the removal are; overgrown, possible sewer damage, litter/debris, sidewalk damage, and a potential trip and fall hazard from fallen leaves onto the sidewalk. There are no additional signatures on the Mutual Request Form (Attachment 2).

The tree was last pruned in December 2017; future scheduled trimming is tentatively scheduled for fiscal year 2021. The height of the tree is approximately 40 feet with a trunk diameter of approximately 23 inches. The tree is directly adjacent to the split rail fence, three feet from the v-ditch/storm drain, six feet from the sidewalk, and approximately 15 feet from the manor.

DISCUSSION

At the time of inspection, the tree was found to be in fair condition, with an unbalanced canopy, no noticeable trunk damage, or pest or disease. There are several pockets of decay and deadwood throughout the canopy as well as a number of very large surface roots which are typical for this species of tree. There is major damage to the V-ditch/storm drain due to the aggressive surface rooting.

Due to the proximity of the tree to the V- ditch, root trenching is not recommended as it would leave the tree unstable. In July of 2012, the sidewalk and several large tree roots were removed and a new sidewalk was installed at a cost of \$1,633. There are no records of a mainline stoppage at this location. Unfortunately, the roots of this tree will continue to cause further damage resulting in higher repair costs if tree is not removed.

FINANCIAL ANALYSIS

The cost to remove the tree is estimated at \$6,900; the estimated value of the tree is \$5,882 based on the tree inventory data.





- <u>Litter and Debris</u>: Because all trees shed litter seasonally, generally this is not an adequate reason to justify removal. However, if granted, removal/replacement may be at the resident's expense.
- <u>Personal Preference</u>: Because one does not like the appearance or other characteristics of the tree or plant generally does not justify its removal. However, if granted, removal/replacement is usually at the resident's expense.
