1. Call to Order

2. Acknowledgment of Media

3. Approval of the Agenda

Director Gilmore made a motion to approve the agenda. Director Liberatore seconded. The committee was in unanimous support.

4. Approval of the Meeting Report for October 10, 2019

Director Liberatore made a motion to approve the report. Director Gilmore seconded. The committee was in unanimous support.

5. Chair's Remarks

Chair Armendariz stated he is looking forward to chairing these meetings. Landscaping is important to all of our residents, as something we see every day.

6. Member Comments

United Landscape Committee December 12, 2019 Page 2

Cass Poole (97-G) A mess was left after trees and mowing were done. There was a tree which was cut down and stump is still there. She was told it would be four months before it comes out. The lawns get really bad when the mowers make U-turns with the mowers. Also, she feels it improper when staff drives a minivan onto the lawn.

Gael Flores (645-A) She has dead and dying plants in her area. Some were removed. The lilies in the walkway are gone and nothing was planted in their place. Her landscaping has been going downhill over the last year and a half. It looked so beautiful when she moved here 12 years ago. Across from her, in a Common Area, a quarter of the plants there are dying and others look bad. Lantana was cut out when sewer lines were worked on. They were left for a long time on the tarps until staff was called.

Sonia Appell (821-N) She and her neighbors have concerns about the lawn in front of 821-P. Big patches where nothing grows. She has contacted landscaping but no follow up. (Records do not indicate any calls regarding lawns for this building in the last year).

Jean Bender (2037-B) Why do they blow the trimmings into the flower beds? The mower doesn't have catchers on them. A lady fell down in front of the pine trees after the rain. Needles are blown back onto lawn and sidewalk. Trees are growing on her tile roof again. Can someone come out and look at this?

7. Response to Member Comments

Mr. Wiemann responded:

- In the 2020 budget, there is money for us to renovate turf in United. In the spring, we will aerate and over-seed the lawns. Lawns will look great this summer. Rabbits are a big problem.
- About the grass, we are continually working on changing the culture about how it is mowed.
- Mulching mowers leave grass behind. We don't have staff to blow sidewalks on a weekly basis. We are doing some work with vacuums for the clippings.
- 15 new mowers for 2020 should take care of the mulch mower issue.
- He asked Ms. Flores to fill out a Landscape Request Form to have those dying bushes addressed.
- Stumps are taken out in groups and he will make sure that Ms. Poole is on the list for the next time Staff will be removing them.

Chair Armendariz said to make sure you have made a service request with Resident Services or filled out a Landscape Request Form.

Mr. Wiemann reviewed the project log with the committee and answered some questions.

10. Approve Tree Trimming Schedule

Chair Armendariz and Mr. Wiemann spoke about the fact that the Village has been on a 34-month trimming schedule and explained how species-based trimming will work. The proposal presented by Mr. Wiemann is to change from a 34-month tree trimming schedule to a species-based tree maintenance program on a five year rotation.

Director Gilmore moved and Director Liberatore seconded. All were in favor of the motion to change to a species-based tree maintenance program.

Mr. Wiemann explained that he is proposing to require Members to fill out a Landscape Request Form to request planting in some of their own plants adjacent to their unit. The committee unanimously approved staff's recommendation.

STAFF REPORT

DATE: February 13, 2020 FOR: Landscape Committee SUBJECT: Request for Tree Removal – 126-T Avenida Majorca (Kruce) – One Canary Island Pine tree

RECOMMENDATION

Deny the request for the removal of one Canary Island Pine tree located at 126-T and trim on schedule.

BACKGROUND

Mr. Kruce became a Member in June 2018. He is requesting the removal of one Canary Island Pine tree, *Pinus, canariensis,* located in the shrub bed area behind the unit; this is the shorter of the two Pine trees in the pictures (Attachment 1). The reasons cited by him for the removal are structural damage, overgrown, and the potential for failure causing extreme danger. Six additional residents have signed the Mutual Request Form in favor of the removal. (Attachment 2).

The tree was last trimmed in May 2017, and future scheduled trimming is tentatively scheduled for fiscal year 2022. The tree is approximately 40 feet in height with a trunk diameter of approximately 27 inches and is growing approximately two feet from the walkway and approximately 12 feet from the building and the unit's patio.

DISCUSSION

At the time of inspection, the tree was found to be in fair condition with a balanced canopy with a self-adjusting lean, no visible decay, no pests, and no trunk damage. There is no noticeable surface rooting or damage to the concrete walk and the tree has a well-developed trunk flare at ground attachment. The tree has been previously topped due to an infestation of the Poly Shot Hole Borer which has been attacking Pine trees in Southern California. In the past, staff has topped Canary Island Pines three to four feet below the affected areas in an effort to preserve the trees which has been successful with a number of trees, including this one.

FINANCIAL ANALYSIS

The cost to remove the tree is estimated at \$1,900, cost to trim is estimated at \$400, and the estimated value is \$5,526, based on tree inventory data.





RECOMMENDATION

Approve the request for the removal of one Indian Laurel Fig tree located at 2183-P.

BACKGROUND

Mr. Italiano became a Member in August 2012. He is requesting the removal of one Indian Laurel Fig tree, *Ficus, microcarpa, "Nitida"*, located on the slope area in front of the building (Attachment 1). The reasons cited by him for the removal are structural damage, litter/debris, overgrown, and the potential of root damage to the building foundation. Four additional residents have signed the Mutual Request Form in favor of the removal. (Attachment 2).

The tree was last trimmed in January 2018, and future scheduled trimming is tentatively scheduled for fiscal year 2020. The tree is approximately 36 feet in height with a trunk diameter of approximately 24 inches and is growing approximately eight feet from the building and approximately one foot from the V ditch.

DISCUSSION

At the time of inspection, the tree was found to be in fair condition with a very large, full, and heavy canopy with end weight on the branches. No visible decay, pests, or trunk damage. There are a number of very aggressive surface roots causing damage and rising of the concrete "V" ditch as well as at the mortar-less block retaining wall. These surface roots that are attached to the trunk do have hollow pockets below them which leads staff to believe there is weak attachment to the slope. There was no noticeable structural damage to the unit or visible surface roots at the foundation.

Due to the location of the tree, it is not possible to perform a root trench and any removal of these roots could cause the tree to become unstable. This species of tree is prone to large surface roots and will continue to cause damage to the "V" ditch as well as potential damage to the building's foundation. It is therefore staff's recommendation to remove the tree as it has outgrown the area and there is no way to control future surface root growth.

FINANCIAL ANALYSIS

The cost to remove the tree is estimated at \$2,000, cost to trim is estimated at \$400, and the estimated value is \$4,681, based on the tree inventory data.



DATE: February 13, 2020 FOR: Landscape Committee SUBJECT: Request for Review of Landscaping –B895 Ronda Sevilla – Mutual Landscape Area

RECOMMENDATION

Direct Staff to trim common area landscape along the garden area pathway at a height of four feet.

BACKGROUND

This is a resident dispute between the Rubins, who purchased in 1994, and the Pisos, who purchased in 2015. There is an existing improvement to the common area that has created a quiet garden area with bench seating and views of the surrounding hillsides. This garden area was constructed in 2006 by the Mutual at the direction of the Board and has been traditionally maintained by the Mutual.

DISCUSSION

The Landscape Department has received two separate Landscape Request Forms from residents adjacent to the area in question; Kathleen Rubin, 895-A, requested that the plants along the pathway be removed, Luis and Mila Piso, 895-D, requested that the plants be left as they are. Staff has met with both parties on several occasions to resolve the dispute, to no avail. The parties have stated that they will abide by the Board's decision.

Staff has reviewed the area and determined that the plants along the walkway can be trimmed to a height of 4 feet, which will give them a neat appearance, protect the view of the hillsides from the park while maintaining the secluded feel of the area.

FINANCIAL ANALYSIS

The cost to maintain this area is contained in the 2020 Business plan.



Location: Right side of the path leading to the Mini-Park on the south side of Building 895 Ronda Sevilla and the area near the boundary fence

Description: Resident plantings in the common area at the base of the United Mini-Park which was intended for use by all Laguna Woods Village residents deter its use. This little park was a unique Village space for residents to sit in quiet and enjoy a long vista across the valley to the coastal mountain range and a place where neighborhood gatherings are held.

The plantings originally placed in this area were low to the ground. The current plants grew to over 8 feet tall. They obstruct the view and the unusual airflow that cools every evening, especially during the summer. Special watering was added using more water than in the past.

These unauthorized plantings deter resident walkers access to the Mini-Park. When walkers approach they stop, turn around and leave not able to take advantage of the lovely walk and park setting or the benches placed around Building 895. Both local neighborhood residents and walkers think it is a private area, worry they are trespassing, not allowed, and leave.

I request that unauthorized plantings be removed from the common area.




