CALL TO ORDER

Erwin Stuller, President of the Golden Rain Foundation, acted as Chairperson of the meeting, called the meeting to order at 11:00 A.M. and stated that the meeting was held pursuant to notice duly given.

ACKNOWLEDGEMENT OF PRESS

Ms. Janet Whitcomb from the Laguna Woods Globe was acknowledged as present.

Mr. Johns provided a brief summary of the history of the transfer fee and GRF's prior attempt in changing legislation to charge the fee, and stated that GRF is interested in re-evaluating its efforts to pursue legislation to allow charging a Transfer Fee.

Mr. Johns introduced GRF Director Bob Hatch who instigated the idea that GRF attempt to re-instate the fee. Mr. Hatch stated that pursuing the legislative effort to reinstate the fee would be an inexpensive way to prevent potential special assessments in the Village and other aging HOA's.

Ms. Wendy Bucknum spoke on the results of a "Reserve Funding" Transfer Fee Interest electronic survey that was distributed to approximately 100 prospective/interested parties in the HOA industry asking for their input regarding their interest in pursing the effort to reinstate a "reserve funding" transfer fee.

United Director Curtis asked questions on the cost incurred on the survey. Mr. Johns advised that there was no cost to the Community.

Mr. Johns introduced Mr. Ronald Kingston from the California Political Consulting Group who provided a brief background on his expertise as a lobbyist in common interest developments and the number of measurable and significant changes he made in CID law, specifically on the law which now prohibits HOA's to charge a transfer fee.

He provided a brief background on the reason GRF's first attempt to pass a bill to change the law a few years ago failed, but stated that CID laws have changed and that now is a good time to pursue legislative efforts. He stated that GRF should not pursue the legislation by itself, but instead, by way of a grass roots approach.

Mr. Kingston spoke on a proposal for a three part study and action plan to pursue Common Area Development Transfer Fees and Assessment Opportunities.

GRF Director Burns Nugent left the meeting at 11:46 A.M left the meeting and did not return.

Third Director Stanley Feldstein left meeting at 11:49 A.M. and did not return.

The Directors were given the opportunity to address their questions to Mr. Kingston and it was addressed that the benefits of the fee would put money in reserves and potentially decrease assessments.
