# MEET THE CANDIDATES MEETING PROTOCOL

This event will be held in the board room and virtually. The virtual meeting link will be sent to the GRF Board, corporate members (United, Third and Mutual 50) and the candidates.

## This event features three parts:

- 1. Opening statements by all candidates.
- 2. Prepared questions asked by the moderator.
- 3. Closing statements by all candidates.

#### **Presentations:**

- 1. The moderator introduces each candidate.
- 2. The moderator asks each candidate to make a three-minute opening statement.
- 3. The order in which the candidates speak is determined by the moderator.
- The assistant corporate secretary tracks the time and informs candidates when 30 seconds are left on the Granicus timer and when time is complete. The moderator will require candidates to hold to the time limits.

## **Question and answers:**

- 1. Prepared questions:
  - Prepared questions are directed to all candidates.
  - The moderator asks the questions by rotation. Each candidate will receive a different question except for the last, which everyone will answer.
  - All candidates have a three-minute opportunity to address each question.
  - The assistant corporate secretary tracks the time.
- 2. There will be no questions from the outside. Candidate will receive 25 prepared questions to answer on their own one week in advance.
- 3. Candidates may use any notes they made to answer the questions but are limited to three-minute responses.

## **Closing statements:**

Each candidate is limited to a three-minute closing statement.
