## APPROVAL OF AGENDA

President Rothberg moved, and Treasurer Amado seconded adding items 4(r) Booster Domestic Water Pumps, 4(s) Year 3 of 5 – Sprinkler System Replacements, and 4(t) A/C Riser Replacements were added to the agenda. By unanimous consent, the Board approved the amended agenda.

# 2019 CAPITAL EXPENDITURE PLANNING

## Replace Building Electrical Breaker

By unanimous consent, the Board voted to include \$153,000 for the replacement and retrofitting of the Building Electrical Breaker in the 2019 Capital Expenditure Plan.

# **Asphalt/Slurry Coat Carport Parking Lot**

By unanimous consent, the Board voted to include \$20,500 to Asphalt/Slurry Coat the Carport Parking Lot in the 2019 Capital Expenditure Plan.

## **Generator Wiring Upgrade**

By unanimous consent, the Board voted to include \$9,300 to add a Generator Wiring Upgrade in the Maintenance Shop in the 2019 Capital Expenditure Plan.

# **Staff Bathroom Remodel**

By unanimous consent, the Board voted to include \$18,000 for a Ground Level Staff Bathroom Remodel in the 2019 Capital Expenditure Plan.

# Replace Steam Cooker

By unanimous consent, the Board voted to include \$11,150 for the replacement of the oven/steam cooker in the 2019 Capital Expenditure Plan.

# **Engineering to Re-Waterproof Ground Floor of the Building**

By unanimous consent, the Board voted to include \$10,000 for engineering work to rewaterproof ground floor of the building in the 2019 Capital Expenditure Plan.

# **Engineer Curb Cuts in Lower Parking Lot**

By unanimous consent, the Board voted to decline \$10,000 for engineering work to install curb cuts in the lower parking lot in the 2019 Capital Expenditure Plan.

# Increasing Lighting in Front of the Building

By unanimous consent, the Board voted to include \$5,000 to increase lighting in front of the building in the 2019 Capital Expenditure Plan.

# **Update Building Monument Signs**

By unanimous consent, the Board voted to include \$10,000 to update building monument signs around the building in the 2019 Capital Expenditure Plan.

# First Floor Common Area Remodeling

By unanimous consent, the Board voted to decline \$600,000 for first floor common area remodeling in the 2019 Capital Expenditure Plan. By unanimous consent, the Board requested Staff present this item at a July Residents' Forum.

# Air Curtains for Sliding Glass Doors

By unanimous consent, the Board voted to decline \$14,400 for air curtains for sliding glass doors in the 2019 Capital Expenditure Plan.

#### **Lortscher Hall Acoustics**

By unanimous consent, the Board voted to include \$32,450 for Lortscher Hall Acoustics in the 2019 Capital Expenditure Plan.

#### **Koi Pond Renovation**

By unanimous consent, the Board voted to include \$10,000 for Renovations to the Koi Pond area, including replacement with fountain/garden, in the 2019 Capital Expenditure Plan.

## Perimeter Fencing Upgrade

By unanimous consent, the Board voted to decline \$97,000 in perimeter fencing upgrades in the 2019 Capital Expenditure Plan.

#### Shade Sail for Zen Garden

By unanimous consent, the Board voted to include \$6,000 for shade sails for the Zen Garden in the 2019 Capital Expenditure Plan.

### **Exercise Room**

By unanimous consent, the Board voted to decline \$22,000 for an exercise room and equipment in the 2019 Capital Expenditure Plan.

# **Design/Construct Dog Park on Property**

By unanimous consent, the Board voted to decline \$6,000 for the design/construction of a dog park on association property in the 2019 Capital Expenditure Plan.

## **Domestic Water Booster Pumps**

By unanimous consent, the Board voted to include \$30,000 for Domestic Water Booster Pumps in the 2019 Capital Expenditure Plan.

## Year 3 of 5 – Sprinkler System Replacements

By unanimous consent, the Board voted to include \$50,000 for Year 3 of 5 – Sprinkler System Replacements in the 2019 Capital Expenditure Plan.

## A/C Riser Replacements

By unanimous consent, the Board voted to include \$69,750 for three A/C Riser Replacement stacks in the 2019 Capital Expenditure Plan.
