Review of the Proposed 2024 Business Plan – Version 3

Multiple members of the community shared their opposing opinion regarding the reduction in duration of cleaning services for the Garden Villa Rec Rooms being weekly to bi-weekly.

A motion was made and moved by Director Jules Zalon to recommend adding \$198,431K (\$2.71 PMPM) to bring weekly cleaning services to the 3-story buildings. Director S.K. Park seconded. Discussion ensued. Director Ira Lewis made a motion to table the original motion. Director Cush Bhada Seconded. The motion to table this item passed by a 5-1-1 vote (Director Zalon voted no and Director Park abstained).
