## INTRODUCTION OF CANDIDATES

Following a brief discussion by Board Members, a second ballot was distributed to all members and, as a result of the second tally, Mr. Jules Zalon was announced as the Third Laguna Hills Mutual Board Director to fill the vacancy for the term ending in 2018.
