

SUBJECT: Tree Removal Request: One Fern Pine Tree located at 2151-D Ronda

Granada

RECOMMENDATION

Approve the request for the removal of one Fern Pine tree located at 2151-D Ronda Granada.

BACKGROUND

The requestor became a Member in March 2023, and is requesting the removal of one Fern Pine tree, *Podocarpus, gracilior,* located in the shrub bed area at the front of the unit.

The reasons cited for the removal request are potential foundation damage, damage to surrounding sidewalk and view obstruction. There are six additional signatures on the Landscape Request Form in favor of the removals (Attachment 1).

The tree was last pruned in 2021. Future trimming is tentatively scheduled for fiscal year 2025. This tree species is on a four-year trimming cycle.

The height of the tree is approximately 30 feet, with a trunk diameter of approximately 12 inches. The tree is growing approximately six feet from the common walkway and six feet from the wall (Attachment 2).

DISCUSSION

At the time of the inspection, the tree was found to be in good health with an unbalanced canopy due to clearance trimming away from the unit. There were no signs of pests or pest activity, and no deadwood or decayed branches. There were no signs of trunk damage, however, surface roots were present. View obstruction is not a legitimate reason for a tree removal and was not taken into consideration.

There is damage to the sidewalks as well as the block wall. The wall has been pushed out by the roots, evident by the wall leaning outward. The wall is also lifted, cracked and the blocks have separated. There are visible roots in the location of the block wall. The cracks in the sidewalk originate from the same area as the block wall damage.

There is not sufficient space to perform a root trenching, doing so would put the tree in an unstable situation. It is staff's recommendation to remove the tree prior to additional damage and plant a slow growing tree in the turf area adjacent to the planter area.

FINANCIAL ANALYSIS

The recurring cost to trim the tree is \$156. The estimated cost to remove the tree is \$828. The estimated value of the tree is \$3,021 based on the tree inventory data. The cost to plant a 15-gallon tree is \$199. The cost to plant a 24-inch box tree is \$399.






