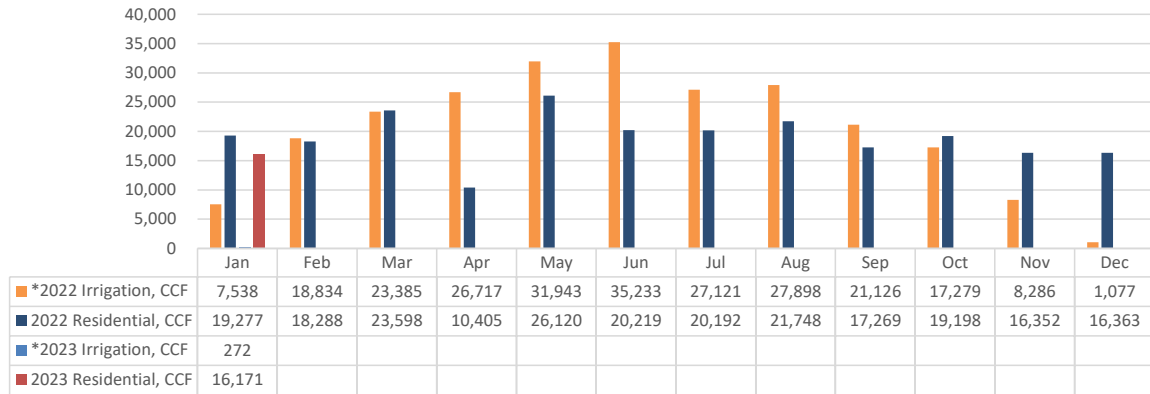

SUBJECT: Tree Removal Request: 370-B – Two Sweetshade Trees

RECOMMENDATION

Approve the request for the removal of two Sweetshade trees located at 370-B Avenida Castilla.

BACKGROUND

The requestor became a Member in July 2022, and is requesting the removal of two Sweetshade trees, *Hymenosporum flavum*, located in the shrub bed area at the front of the unit.

The reason cited for the removal request is conflict with shrubs. There are four additional signatures on the Mutual Request Form in favor of the removals, including unit C where the second tree is located (Attachment 1).

The trees were last pruned in October 2019. Future trimming is tentatively scheduled for fiscal year 2024. This tree species is on a five-year trimming cycle.

The height of the trees is approximately 20 feet, with a trunk diameter of approximately 5 inches. The trees are growing approximately five feet from the common walkway (Attachment 2).

DISCUSSION

At the time of the inspection, the trees were found to be in fair health with unbalanced canopies. There were no signs of pests or prior pest activity. There was some deadwood in both canopies and no decay present.

There was cross limb growth of both trees. This is when limbs are growing over other branches in an opposite direction. This characteristic will cause eventual damage to the limbs. There were no surface roots visible or any damage to the walkways.

The trees are interfering with the growth of the two multi trunk Pygmy Date Palms, *phoenix robillini*. Crown raising the trees to avoid conflict with the palms would eventually result in a heavy canopy with no lower growth on the trunk.

It is Staff's recommendation to remove the two Sweetshade trees now when they are relatively small with a minimal cost of removal.

FINANCIAL ANALYSIS

The recurring cost to trim the trees is \$156 each. The estimated cost to remove both trees is \$621. The estimated value of the trees is \$700 each based on the tree inventory data.

SUBJECT: Supplemental Appropriation for Water Saving Landscaping

RECOMMENDATION

Approve a supplemental appropriation in the amount of \$86,000 to be funded from the 2022 and \$144,000 from the 2023 Water Expense Account, for water saving landscaping projects within United Mutual.

BACKGROUND

On August 11, 2022, the Board of Directors approved Resolution 01-22-55, directing staff to reduce irrigation water use by 15 percent (Attachment 1).

DISCUSSION

In response to the ongoing drought conditions and the California Governor's mandate to reduce water usage and after direction from the Landscape Committee, staff began reducing irrigation water usage in early July by decreasing run times on shrub beds and reducing watering days for turf, from three days to two. Additionally, during the process of preparing for the new Irrigation Master Control System project, staff was able to identify additional measures to further increase water savings.

These reductions, along with the extended rainy season have lowered 2022 expenditures for water by \$119,215 (Attachment 2). Staff has forecasted these savings to the end of the 2023 fiscal year by comparing actual usage to five- year averages and the budgeted amount for 2023, with an estimated additional savings of \$144,000 for 2023 (Attachment 3).

Turf uses The Landscape Committee has committed to reducing the cost of irrigation water usage in United by reducing non-functional turf areas. Reducing these areas also reduces labor costs by eliminated difficult to maintain and irrigate turf areas. Approving this supplemental appropriation will enable staff to remove approximately 57,000 square feet of turf and replace it with waterwise plantings that are low maintenance.

FINANCIAL ANALYSIS

A supplemental appropriation of \$86,000 to be funded from the 2022 and \$144,000 from the 2023 Water Expense Account for a total of \$263,215, to the Landscape Expense Fund will accomplish the design and installation of water saving landscaping.

RESOLUTION 01-22-55

Irrigation Water Mandate

WHEREAS, July 14, 2022, the Landscape Committee recognized that the State of California is experiencing record drought conditions requiring parts of Southern California to reduce exterior irrigation water use; and

WHEREAS, the current water restriction mandates request a voluntary reduction in potable water use of 15 percent and irrigation water sources in United Mutual are mostly potable water; and

WHEREAS, the Landscape Committee determined that a 15 percent reduction of landscape irrigation is a prudent and proactive approach to the ongoing drought conditions in the region;

NOW THEREFORE BE IT RESOLVED, on August 9, 2022, that a 15 percent reduction in irrigation water use shall be applied to all irrigation within United Mutual; and

RESOLVED FURTHER, this resolution shall become in full force and effect on August 9, 2022; and

RESOLVED FURTHER, that the officers and agents of this Corporation are hereby authorized on behalf of the Corporation to carry out this resolution as written.

**Supplemental Funding for Turf Reduction
Projects**

WHEREAS, August 11, 2022, the United Board of Directors recognized that the State of California is experiencing record drought conditions requiring parts of Southern California to reduce exterior irrigation water use and directed staff to reduce irrigation by 15 percent; and

WHEREAS, the United Mutual Landscape Committee determined that funding for turf reduction projects should be appropriated from savings to the Water Expense account based on savings from these reductions and funded from the Landscape Replacement Reserve Fund; and

WHEREAS, March 27, 2023, the United Mutual Landscape Committee endorsed the recommendation;

NOW THEREFORE BE IT RESOLVED, on May 9, 2023, that a supplemental appropriation of \$86,000 to be funded from the 2022 and \$144,000 from the 2023 Water Expense Account has been approved to be used for water saving landscaping projects within United Mutual; and

RESOLVED FURTHER, this resolution shall become in full force and effect on May 9, 2023; and

RESOLVED FURTHER, that the officers and agents of this Corporation are hereby authorized on behalf of the Corporation to carry out this resolution as written
