SUBJECT: Operating Rules

RECOMMENDATION

Review and provide direction.

BACKGROUND

The Governing Documents Review Committee is tasked to review policy and processes for consistency. The Committee and staff have identified areas of improvement including, but not limited to, the need to revise the Operating Rules Guidebook located on the website.

The Operating Rules Guidebook contains a collection of most referred rules and regulations adopted by the Board. The Committee directed staff to review the guidebook with the following goals in mind:

- 1. Reduce and condense the rules and regulations contained in the guidebook;
- 2. Present the rules and regulations in a readable form; and
- 3. Create hyperlinks to Policies & Procedures included on the Laguna Woods Village website.

The Compliance Division is responsible for the coordination of the rules enforcement program of the Village. Staff reviewed the rules and regulations contained in the Operating Rules Guidebook and created a new version that meets the Committees directive. The changes incorporated in the new Operating Rules Guidebook include, but not limited to: present the rules and regulations by category; removed cancelled rules and regulations; removed resolutions that are not rules and regulations; included a definition section; and an introduction page that explains the enforcement process.

On August 20, 2020, the Committee reviewed the updated Operating Rules Handbook and commended staff on satisfying the objective provided by the Committee. Additionally, Former Chair Andre Torng will meet with staff off line to discuss further objections regarding the Operating Rules and possible cost associated in implementing of same.

On September 2, 2020, Former Chair Torng and staff met to discuss his objectives further. The objectives were forwarded to the appropriate department for review.

On November 2, 2020, President Sue Margolis and staff met to discuss the Operating Rules Guidebook. President Margolis directed staff to work with the Landscape Department on what rules to include and review the hyperlinks. President Margolis informed staff that any

additionally items would be discussed at a future Governing Documents Review Committee meeting.

DISCUSSION

Staff is working with the Landscape Department to ensure that the proper operating rules are included in the Operating Rules Guidebook. Additionally, staff continues to review the document for efficiency.

AB 3182 Checklist

As you likely know, Assembly Bill 3182 ("AB 3182") recently passed and will go into effect January 1, 2021. Under AB 3182, any provisions of the governing documents which "unreasonably restrict" renting will be void and unenforceable, with limited exceptions.

In light of the new law, we want your community to be prepared and have created an "AB 3182 Checklist" to assist you in evaluating the next steps to take.

- · Review Governing Documents for Any Rental Restrictions.
- Determine Whether any Said Rental Restrictions Violate AB 3182:
 - Rental Cap;
 - · Minimum Lease Term;
 - · Occupancy Requirements; or

- Any other provision that may potentially be deemed an "unreasonable" restriction on leasing.
- Decide Whether to Amend/Revise Governing Documents to:
 - 1. Comply with AB 3182; and/or
 - 2. Include New, Legally-Compliant Rental Restrictions.
- Prepare Amendment and Voting Documents (i.e., Secret Ballots, etc.).
- Prepare Revision(s) to Rules and Regulations (if applicable).

Again, it is critical that the Board act now to ensure your community is protected and liability is limited. Failure to amend your governing documents could result in current rental restrictions being invalidated (starting January 1, 2021) and monetary penalties imposed (starting December 31, 2021).

Please let us know how Beaumont Tashjian can be of assistance to your association. Please note, for a flat fixed fee, our office can perform the necessary review of your governing documents to determine if the association is in violation of AB 3182, and thereafter guide the Board through amending the governing documents, as needed.
