EVALUATING DIRECT POTABLE REUSE REQUIREMENTS AND OPPORTUNITIES

The California State Water Resources Control Board recently adopted new regulations regarding Direct Potable Reuse (DPR). The regulations are protective of public health and are among the most rigorous potable reuse regulations and requirements in the nation. The rules contain stringent regulations for emerging contaminants and ensure that all final DPR water produced meets or exceeds all drinking water standards.

What is Direct Potable Reuse?

The process of using purified wastewater for drinking water is known as potable water reuse. Potable water reuse can help expand a region's water resource portfolio. As described by the U.S. EPA, there are two types of potable water reuse.

- Indirect potable reuse: introduction of highly purified recycled water into an environmental buffer for a specified period of time before being drawn for potable purposes.
- Direct potable reuse: introduction of highly purified recycled water directly into the drinking water distribution system or a drinking water treatment plant.

What do DPR Regulations Mean for ETWD?

ETWD does not have access to an environmental buffer, so DPR regulations allow ETWD to consider potable reuse as a potential option in its water supply portfolio. All of ETWD's water supply is imported, so exploring potable reuse offers benefits, such as enhanced resiliency, reliability, and lower greenhouse gas emissions compared to imported supplies. However, implementation of a DPR project would take time, funding and extensive public outreach. In the meantime:

- ETWD does NOT currently use wastewater as a source of drinking water supply.
- ETWD's current drinking water comes from the Metropolitan Water District of Southern California who provides extensively treated water from the California State Water Project and the Colorado River.
- ETWD intends to conduct a careful evaluation of the opportunities, requirements/regulations, and costs associated with Direct Potable Reuse.
- ETWD is committed to ensuring that any decision aligns with the highest standards of public health and environmental protection.

KEEP WIPES OUT OF YOUR PIPES

Only Flush the Three P'S - Pee, Poop and (Toilet) Paper

- Wipes are convenient, but they are not safe to flush down the toilet even if they are labeled "flushable" or "disposable."
- Flushing wipes creates nasty clogs and fatbergs (collections of grease and debris floating in the wastewater) that can cause sewer system backups and spills that can damage your home and our environment.
- Do not flush wet wipes, such as baby wipes, surface cleaning wipes, cosmetic wipes, etc.


FIX A LEAK WEEK

March 18 - 24, 2024

Fix a Leak Week encourages Americans to help put a stop to the nearly 1 trillion gallons of water wasted from household leaks each year. ETWD is asking consumers to find and fix leaks to save water in our community.

To help save water for future generations, ETWD is asking consumers to check, twist and replace:

• CHECK FOR LEAKS. Look for dripping faucets, showerheads, sprinklers and other fixtures. To check for silent toilet leaks, place a few drops of food coloring into the tank, wait 10 minutes, and see if color appears in the bowl before you flush. Remember to check irrigation systems and spigots, too.



- TWIST AND TIGHTEN HOSE AND PIPE CONNECTIONS. To save water without a noticeable difference in flow in your bathroom, twist on a WaterSense labeled faucet aerator.
- **REPLACE THE FIXTURE IF NECESSARY.** Look for WaterSense labeled models, which are independently certified to use 20% less water and perform as well as or better than standard models. Visit **www.epa.gov/watersense** to find products.

SPRING INTO SAVINGS WITH REBATES 🏠

Refresh your home and landscape this spring with water-saver rebates. Here's a list of currently available indoor and outdoor rebates for ETWD customers.

Residential Outdoor Rebates

PROGRAM/DEVICE	REBATE LEVEL (AS OF MARCH 4, 2024)
Smart Irrigation Timer	Up to \$180
Soil Moisture Sensor Controller	Up to \$180
Rotating Sprinkler Nozzles	Up to \$2 per nozzle
Drip Irrigation	\$1/sq. ft. up to 5,000 sq. ft.
Rain Barrels and Cisterns	Up to \$50 per rain barrel and \$250 - \$350/cistern
Turf Removal	\$4 sq. ft. up to 5,000 sq. ft. (annual maximum)*

Commercial Outdoor Rebates

PROGRAM/DEVICE	REBATE LEVEL (AS OF MARCH 4, 2024)
Turf Removal	\$3/sq. ft. (up to 5,000 sq. ft.*)
Turf Removal (Public Agency)	\$4/sq. ft. (up to 200,000 sq. ft.*)
Treebates	\$100/tree (up to 5 trees and must be a part of a turf removal project)
Drip Irrigation	\$1/sq. ft. (Commercial up to 50,000 sq. ft./Public Agency up to 200,000 sq. ft.)
Smart Irrigation Timers	\$50/station

*Turf rebates do not apply to designated recycled water sites. If you have already removed your turf, your project is not eligible for this program. Additionally, projects must not be started prior to the receipt and acknowledgement of this Program's Letter to Proceed.
