


RECEPTION TO CELEBRATE LAUNCH OF VILLAGE CENTENARIAN PROJECT



Did you know 76 Residents age 100 and older are living in Laguna Woods Village? During a special reception Friday, June 28, from 2 to 3:30 p.m. at the Community Center Board Room, celebrate the launch of the Village Centenarian Project and learn more about the lives and times of more than a dozen of your most experienced neighbors. Sponsored by the Thrive Task Force and produced in cooperation with the Camera Club, the Video Club and the Department of Recreation and Special Events, this event will feature past and current portraits of 16 project centenarians, as well as a video preview of three 30-minute television programs containing participant interviews. Refreshments will be served.

The Village Centenarian Project will be on display at Clubhouse 2 during the Village's July 4 celebration event and during Grandparents' Fun Day, scheduled for Saturday, August 3. The television programs are scheduled to air on Village Television during July, and the entire project—portraits and interviews—will be posted to the Village website late this summer.


CONSIDERING A BOARD RUN FOR YOUR MUTUAL BOARD? MEET WITH YOUR DIRECTORS



VMS CEO RECEIVES HISTORY CENTER ANNIVERSARY BOOK





ASPHALT CRACK FILL WORK SCHEDULED FOR JUNE




The Transportation division will be performing asphalt crack fill work prior to sealcoating throughout the Village during the month of June. The schedule is as follows:

- United Mutual:** Crack fill will take place from Monday, June 10, to Wednesday, June 12, at culs-de-sac 18, 30/32, 39, 46, 49, 51 and 59.
- Third Mutual:** Crack fill will occur Thursday, June 13; Friday, June 14; and Monday, June 17, to Thursday, June 20, at cul-de-sac 31, 33, 202, 319, 329, 337, 338, 340-B, 341, 376, 3328, 3347, 3351, 5318, 5339, 5368 and 5369.
- On GRF property:** Crack fill will take place Friday, June 21, and Monday, June 24, to Friday, June 28, at Alta Vista (Via Vista to Via Buena Vista), Belmez (Avenida Despachio to end), Calzado (Duenas Street to end), Cantante (Del Sol to end), Clubhouse 1 (entire parking lot), Clubhouse 1/Library (parking lot south of Library) and Monte Hermoso (Avenida Sosiega to Bahia Blanca).

Paving Staff will block off designated areas in affected culs-de-sac and streets to perform necessary services.

VILLAGE TELEVISION PAUSES OVERNIGHT BROADCAST JUNE 14



So that crews may perform scheduled equipment installations on the Community Center HVAC system, electrical power to the center will be shut off temporarily overnight starting Friday, June 14. Village Television will pause its regularly scheduled programming on Friday, June 14, starting at 9 p.m. Normal broadcasting will resume on Saturday, June 15, at 10 a.m.

GATES 1 AND 9 REOPEN JUNE 17 GATES 4, 10 AND 14 CLOSE JUNE 24



Gates 1 and 9 remain closed to vehicle traffic for the radio frequency identification decal (RFID) retrofit but will reopen Monday, June 17. Gate 1 continues to allow for pedestrian and golf access; Gate 9 allows for pedestrian access.

Gates 4, 10 and 14 are scheduled to close Monday, June 24. Construction is estimated to take six weeks.

TOWN HALL MEETING REGARDING VILLAGE POLLING CENTERS

On Friday, June 21, in Clubhouse 5 from 10 a.m. to noon, the Orange County Registrar of Voters (OCROV) will be holding a community workshop to discuss future polling options in Laguna Woods Village.

The passage of the California Voter's Choice Act (Senate Bill 450) in 2016 now permits counties to conduct elections using vote centers instead of polling places. In February, the Orange County Board of Supervisors voted to move forward with the transition from the polling-place model to the vote-center model. The OCROV currently is reviewing sites to serve as locations for in-person voting in the March 2020 presidential primary election.

According to OCROV, because of constantly advancing technology, the traditional polling place model no longer meets the needs and expectations of Orange County voters. Multiple polling places in a single neighborhood cause confusion with local voters and leave them uncertain about where to vote, claims OCROV.

Voters are gradually changing the way they vote to accommodate their schedules and lifestyles.

In Orange County in the 2016 presidential general election, nearly 700,000 of 1.2 million ballots cast were vote-by-mail ballots. Currently, 61 percent of all registered voters have signed up for permanent vote-by-mail status. The number of voters casting ballots at the polling place has dropped 20 percentage points since 2004.

The OCROV presentation will include an overview of the vote-center model and provide the opportunity for Residents to contribute suggestions regarding the transition. Village Residents also will have an opportunity to ask questions and complete a survey to share their feedback.
